

Council Highlights

EBCC - Request for Extension

The Mackenzie Community Arts Council wrote to Council that they require an extension of the August 1, 2024 eviction date in order to successfully relocate. Council moved to have staff to report on the cost and safety of potentially extending the eviction to September 1, 2025.

MORATA – Letter of Support Request

The Mackenzie Outdoor Route & Trail Association has requested a letter of support from the District towards their Rural Economic Diversification and Infrastructure Program (REDIP) grant application for funding towards the mountain bike trails. Council approved the request.

Community Futures Fraser-Fort George - Letter of Support Request

Community Futures requested a letter of support towards their Rural Economic Diversification and Infrastructure Program (REDIP) application for a grant to help support the Regional Food System mapping Project. Council approved the request.

Remaining Council Travel Funds

Council deferred the decision to discuss and vote on the Remaining Council Travel Funds report until a later date when all of Council was present to be part of the discussion and vote.

Agricultural Information Fair

Council moved that staff organize a one-day agricultural information fair to be held in the fall of 2024.

Official Community Plan Amendment – Development Permit Area Establishment

This report proposed that two Development Permit Areas (DPAs) be established. DPAs are areas where special treatment is required when being developed. The report proposed two DPAs: a Form and Character Development Permit Area, and an Environmental Development Permit Area. Community Grants - September 2023 First In-Take

Council approved the recommendations of the Grant Adjudication Committee for the first intake of the 2024 Community Grants Program. \$135,371.50 has been released, and \$64,628.50 remains to be awarded in the second intake.

Airport Services Agreement Contract Award

Council awarded a two-year Airport Services Agreement to KS2 Management Ltd. in the amount of \$9,650 per month plus GST.

Council re-appointed Camille Ginnver to the Mackenzie Library Board of Directors with a term retroactively beginning January 1, 2023 and ending December 31, 2024, reappointed Anthony Brewis to the Mackenzie Library Board of Directors with a term starting January 2024 – December 2025, and appointed Corinne Higgins to the Mackenzie Library Board of Directors with a term starting January 2024 – December 2025.

Official Community Plan Amendment Bylaw No. 1508, 2023

Bylaw No. 1508 cited as "Official Community Plan Amendment Bylaw No. 1508, 2023" was given the first two readings. This Bylaw would establish "Development Permit Areas" where the lands which need special treatment when being developed. Next steps will be sending the bylaw for referral and hosting a public hearing.
