Public Hearing

A Public Hearing was held for Zoning Amendment Bylaw No. 1518, 2024. The bylaw change would require residents to obtain a permit before placing a temporary (30 days) shipping container on their property. The bylaw also would allow residents to use a shipping container for temporary storage while moving (up to 30 days). No comments were received at the hearing.

Ernie Bodin Community Centre - Donations

The District received requests from the Mackenzie & District Museum, the Mackenzie Autumn Lodge Society, and the Mackenzie Community Arts Council for items to be donated to the relocating tenants. Council passed a motion for the Director of Recreation Services to meet with the tenants to determine which items could be donated to mitigate the cost of renovations to new spaces and which may not be feasible to provide or are being used elsewhere in the District.

Tse'Khene Culture Camp

Council passed a motion to provide lifeguards on site on Saturday August 3, 2024 for the Tse'Khene Culture Camp taking place at Cut Thumb Bay August 2 – 4, 2024.

2023 Annual Report

Council provided opportunity for the public to provide feedback on the 2023 Annual Report. Council later approved the 2023 Annual Report and the final version is available on the District website and Let's Chat Mackenzie.

Access and Inclusion Awareness Committee

Council received a report from the Access and Inclusion Awareness Committee for the second quarter of 2024. The report outlined the committee's activities over the last three months.

CBC Broadcast Facilities License

Council authorized the Chief Administrative Officer to execute a license agreement with the CBC. The agreement is for five years with an annual fee of \$193.08 calculated based on the property value of the land and the area that will be occupied.

2024 – 2034 Canada Community-Building Fund Agreement

Council authorized the Mayor and Chief Administrative Officer to execute a 10-year Canada Community-Building Fund Agreement on behalf of the District of Mackenzie. The new agreement provides the administrative framework for the delivery of the Canada Community-Building Fund (formerly the federal Gas Tax fund) to local governments and other recipients in British Columbia from 2024 to 2034.
