Mental Health and Addictions Accord

Council voted to sign a Mental Health and Addictions Accord. This living document is being developed by the City of Prince George, Regional District of Fraser-Fort George, Lheidli T'enneh, and NCLGA and will be signed by supporting organizations at the Mental Health and Addictions Symposium on November 13-14, 2024, in Prince George. The Accord is a high-level commitment document developed for local governments, mental health agencies, and service organizations across Central and Northern BC. It outlines shared principles and actions for stakeholders to endorse and commit to, emphasizing areas of agreement and joint responsibility.

Remembrance Day Poppy Campaign

Council voted to support the Mackenzie Royal Canadian Legion 2024 Poppy Campaign and will purchase a large wreathe to be displayed at the Municipal Office.

Municipal By-Election All Candidates Forum

Council approved a request to waive the rental, and set up fees for the All Candidates Forum taking place in the Callahan Room at the Rec Centre on November 4th.

Royal Canadian Legion Military Service Recognition Book

Council voted to repeat their sponsorship for the Royal Canadian Legion Military Service Recognition Book. In 2023 Council purchased a business card sized advertisement for \$385.00.

Request for Letter of Support - Hubspace

Council approved a request for a Letter of Support for Hubspace's application for the Rual Economic Diversification & Infrastructure Program to support efforts to expand their programming to rural Northern BC.

2023 Fire Smart Demonstration Project Cost Adjustment

Council voted to award a services cost increase of up to \$7,000 plus GST.

R. King Holdings Ltd. Airport Lease

Council approved a 3-year lease agreement with R. King Holdings Ltd. The lease rate for non-commercial airside in 2024 was \$0.0827/ft2, this amounted to \$3,341.16 in 2024. The 2025 rate for non-airside commercial rent will be \$0.11/ft2 plus GST (\$4,276.85). For the second and subsequent years of the term the base rate will increase by the Consumer Price Index (CPI) for Vancouver.
