### **Letter of Comment – Sunrise Expansion Program**

Council passed a motion to submit a letter of comment following the Enbridge Sunrise Expansion Program Round Table that took place in Mackenzie on February 11, 2025.

### **Union of British Columbia Municipalities – 2025 Membership Dues**

Council moved to pay membership dues to the Federation of Canadian Municipalities for 2025 - 2026 in the amount of \$2,682.76.

### **Letter of Support – Mackenzie Community Arts Council**

Council will write a letter of support for the Mackenzie Community Arts Council's application to the Royal Bank of Canada Communities Investment Grant to help fund the cost of renovations at their new location.

### **Letter to BC Hydro and Water Comptroller**

Council passed a motion to send a letter to BC Hydro and the water controller office to voice their concerns with BC Hydro's request to draft Williston Reservoir below 2150 feet, if necessary.

### **Blood Plasma Donor Centre in Northern British Columbia**

Council will be providing a letter of support, in principle, for the establishment of a Northern BC Blood Plasma Donor Centre, in Prince George.

### **Contract Award – Development Services Program Update**

Council awarded the Development Services Program Update project to Praxis Solutions in the amount of \$34,400 plus GST.

### **Land Referral – Application for a Section 11 Kwadacha Natural Resources Limited Partnership**

In response to the application for a Section 11 Kwadacha Natural Resources Limited Partnership, Council directed Administration to respond in support of the application and had no objections.

### **Vehicle Replacement – 2025 GMC Sierra 1500**

Council awarded the purchase a 2025 GMC Sierra 1500 to Wood Wheaton Supercenter in the amount of \$49,086 plus GST.

### **Bylaws Adopted**

Bylaw No. 1521, 2025, Water Rates and Regulations Amendment, Bylaw No. 1522, 2025, Sewer Rates and Regulations Amendment, and Bylaw No. 1523, 2025 Garbage Rates and Regulations Amendment were adopted by Council.
