

2025 PROPERTY TAXES: IMPORTANT DATES AND REMINDERS

Taxes are due Wednesday, July 2, 2025



AVOID PENALTIES: On July 3, 2025, a statutory penalty of 10 % must be applied to late taxes and unclaimed Home Owner Grant amounts.

The District cannot waive this statutory charge.



CLAIM YOUR HOME OWNER GRANT THROUGH THE PROVINCE OF BC

Claim before July 2, 2025

Apply for your Home Owner Grant directly with the Province online at www.gov.bc.ca/homeownergrant

To be eligible to receive the grant, the home owner must:

- Be the registered owner of the home
- Occupy the residence as their principal residence
- Live in British Columbia and be a Canadian citizen or Permanent Resident of Canada

To avoid interest and penalties, apply ONLINE before the tax due date of July 2, 2025.



DEFERRING YOUR PROPERTY TAX

The Province of BC's Property Tax Deferment Program is a low-interest provincial loan program designed to help qualified BC home owners pay annual property taxes on their principal residence.

HOW TO PAY

There are many ways to pay your taxes

Pay Online - through your financial institution:

Log into your financial institution's online banking system, search "Mackenzie" as the payee, and select District of Mackenzie - Taxes. Use the roll number located on the front of your tax notice as your account number.

NOTE: Online/telebanking and financial institution payments are subject to late payment penalties if rejected by the financial institution for any reason or if the payment is made after the financial institutions' "local cut-off time" on July 2, 2025.

Pay in-person:

Visit the District of Mackenzie office at #1 Mackenzie Blvd during regular office hours and pay by cash, debit card or cheque. Credit cards are not accepted for tax payments. Pay early to avoid waiting in line.

Plan ahead as postal service and financial institution practices affect when funds are delivered to the District.

Due Date: July 2, 2025

Drop off your payment:

After hours drop box is located on the right hand side of the main entrance of the District of Mackenzie office. Payments received after midnight on July 2, 2025 are subject to late payment penalties.

Mail or Courier your payment:

Payment must be received by the due date. The postmark is not accepted as date of payment. Lost, stolen or delayed mail will be subject to late payment penalties if received after the due date.

GARBAGE & WILDLIFE

Garbage Disposal practices are outlined in Bylaw No. 1487 which is available on the District Website.

Owners and occupiers of a property must not place collection carts out for collection prior to 5:00am on the scheduled collection day. Garbage shall not be stored in such a manner that it is accessible to wildlife. Collection cart shall be secured by sufficient means to prevent access by wildlife.

Thank you for complying with all the municipality's garbage bylaws. Let's all stay safe and be BEAR AWARE.

Your Tax Notice

The District collects its municipal portion of the tax, and collects taxes on behalf of other tax authorities (school, hospital, Regional District and others). Assessment values, as determined by BC Assessment, are used to determine the tax rates required to raise enough revenue to cover the annual operating budget.

Municipal Tax Portion: Where your money goes

The municipal tax dollars you contribute help cover the costs of providing:



Utilities

Water, sewer and garbage services are shown separately on the tax notice because they are collected as a user fee, rather than a tax on your property assessment.



Water, sewer and garbage rates are determined through bylaw. This fee is directly related to the cost of providing the services. These services are intended to be self-funded, meaning the full cost of the programs are funded by user fees, including the costs related to managing the life cycle of capital assets. User fees are adjusted annually to offset any changes in the cost to deliver the service.

Residential customers are billed annually for these services on their property tax notice. Residents cannot opt out of these services. Commercial and Industrial customers are billed on a bi-monthly basis depending on the services they use.

Arrears, Delinquent & Tax Sale

Arrears - If property taxes are not paid by Dec 31st of the year they were imposed, they become taxes in arrears and are subject to daily interest.

Delinquent - If property taxes are not paid after two years, they become delinquent and are subject to daily interest. Having delinquent taxes puts your property at risk of being sold at tax sale.

Tax Sale - In accordance with the Local Government Act, the District of Mackenzie may conduct an annual tax sale the last Monday in September by offering for sale by public auction each parcel of real property on which taxes are delinquent. (Delinquent taxes are outstanding taxes from two years prior to the current tax year).

The 2025 Tax Sale date is:
Monday, September 29, 2025
